## **Rural Ontario Institute releases 2019 Foresight Papers**

November 12, 2019 – The Rural Ontario Institute (ROI) recently released the Rural Ontario Foresight Papers 2019 at an event in Cobourg. Following the success of the 2017 edition, the 2019 Papers tackle a variety of rural development challenges and trends. As with the first set of Papers, ROI partnered with the Northern Policy Institute to provide Northern Commentary as well as French translation.

Each Foresight Paper explores a particular topic affecting rural and Northern Ontario. The authors were encouraged to look ahead to what directions various stakeholders, governments or nonprofits might follow in order to foster vital rural development in light of the trends the authors foresee. The 2019 Papers offer an opportunity for rural stakeholders to be informed by the perspectives of these authors and to consider the implications for their own work or their own communities.

"There is so much value in the Foresight Papers released this month. Each of them provides research, analysis and evidence-based perspectives on issues that are challenges for municipalities," says Robin Jones, Mayor of Westport. "Our carbon footprint in rural Ontario, storm water management, workforce development, servicing an aging population are all real issues that are discussed in every Council Chamber. Smaller municipalities lack the resources to contract consultants to develop possible solutions and the Foresight Papers help to fill that gap. It is ROI's intent that the Papers help catalyse further dialogue and discussion which in turn may lead to various agencies in civil society, levels of government and/or rural citizens to consider actions or strategies that will improve rural vitality over the long term. Included with each of the Papers is a corresponding northern commentary prepared by NPI Policy Analysts Hilary Hagar and Amanjit Garcha. The topics for the 2019 Rural Ontario Foresight Papers are:
